

## Rent a FIAT 500 Kft. Fees and Payment Terms

### **Annex 1** to the General Rental Agreement Terms (GRAT)

- 1. The prices published on the website of the Lessor are in Eros (EUR) and include the relevant VAT as it is fixed in the regulations (Rent a FIAT 500 Kft. is a VAT exempt company, our invoices do not contain VAT). The fee payable is calculated at the price valid at the time of the order and confirmed in the order confirmation shall be payable in Euros (EUR), Hungarian Forints (HUF) or if specially requested in other currency should be paid by the Lessee based on the following:
- 2. The Lessor directs the Lessee to its outside service provider site (www.PayPal.com, hereafter 'PayPal') via its website www.rentafiat500.hu payment module, where the Lessee can make payment by internationally approved banking cards through his own payment system. In this way the payment shall occur through the Lessor's website (PayPal). The Lessor only receives such information necessary for the order and Paypal only receives information such that is necessary for the financial transaction. Paypal accepts the following banking cards: Maestro, MasterCard, Visa, American Express.
- 3. In case the website payment module is not available to the Lesse due to a technical or access problems, in order to keep the booking the Customer has the opportunity to notify the Lessor with his intention to pay on the <code>info@rentafiat500.hu</code> e-mail address. In the event the Customer does not wish to pay the rental fee by bank card as it is set out in item 2 regarding PayPal, or wishes to pay in Forints or other currency (he is able to a comment in his order), than the Lessee will receive an email reply that includes the necessary information for a bank transfer (not through PayPal) and this way the Customer can pay the rental fee to the Lessor directly. The payment will happen by bank transfer or bank card in such case as when the order does not happen through the website's payment module for some reason.
- 4. The Lessor cannot accept cash payment due to local regulations in force.
- 5. In case of payment by PayPal, the system will advise the successful or unsuccessful receipt of payment and the Lessee will receive a confirmation email regarding the order. In case the payment is not made through the payment module the customer will receive information (in an e-mail) about the success of his payment.
- 6. Within 5 days of the payment receipt we will issue an advance payment confirmation on the amount paid and once the use of the service has completed (Date of Handover Minutes and Condition Report) we will issue the final invoice within 15 days. If the Lessee did not use any services other than as specified in the order and there are no further items to be charged, the final invoice will be issued with the sum of zero.

- 7. Both the advance and final invoices are electronic and will be sent to the email address specified by the Lessee. The base for the calculations is the EUR price finalized trough the booking system. Upon finalisation of the order the Lesse agrees to accept the invoice only in an electronic format due to the regulations as set out in the Civil Code CXXVII Act, 175§, item (3) b) 2007, on VAT regulations based on the following:
  - a. In case of payment in EUR currency through Paypal or a bank card: The price finalized in Euros at the booking will be invoiced in Euros.
  - In case of a bank transfer in Euros:
     The price finalized in Euros at the booking will be transferred in Euros to the bank account given and the invoice will be issued in Euros.
  - c. In case of bank transfer in HUF:
    The price finalized at the booking in Euros will be converted into HUF based on the official exchange rate published by the MNB (www.mnb.hu) on the day of the order. The Lessee transfers the amount in HUF to the given HUF bank account and the invoice will also be issued in HUF.
  - d. In case of payments in other currencies, the cost of the conversion will be paid by the Lesse and the invoice will be issued in EUR or HUF.

We will be following the above in case of extra services or other items to be calculated and added to the invoice

In case the Lessee wishes to have the invoice in a different format from the one given at the time of the order, he will need to confirm in writing as a comment or in an email to the Lessor.

- 8. In order for the Lessee to be able to meet his obligations as set out in the Rental Agreement he needs to pay 400 EUR deposit (rounded sum: 140 000 HUF) before receiving the vehicle based on the following:
  - The amount of the deposit should be provided in HUF, directly before picking up the vehicle through a transaction on the Lessor's POS terminal with a bank card transaction.
  - Banking and Credit cards accepted by the POS terminal are: Maestro, Maestro Paypass, MasterCard, MasterCard Electronic, MasterCard Paypass, Visa, Visa Electron, VPay.
  - Through the transaction, with the approval of the Lessee the amount will be blocked on his account based on the Lessor's accepting bank's pre-approval. The deposit if it was not impaired will be released within 15 days after the expiry date of the rental agreement upon the notification from the Lessor. After initiating the release, the Lessor is under to obligations with regards to the deposit and with regards to the banking services. In case the deposit is not used the Lessor will not charge or invoice on any money movement regarding the deposit.

In case the deposit is used partly or in whole, the Lessor will issue an invoice accordingly based on item 7 of the current document.
