TERM 4. – Fees of this Car Rental Agreement

TERM 5. – Lessee's declarations:

- Lessee declares he as a driver and the identified 2nd driver have all the skills and knowledge needed for driving safely the rented vehicle, and has a valid driving licence for more than 1 year.
- Lessee declares that before signing this Car Rental Agreement he has read carefully and understood Lessor's General Rental Agreement Terms (GRAT), accepts its' terms and expresses himself to be bound by GRAT.
- Lessee declares that he received the vehicle owned / operated by Rent a FIAT 500 Kft. specified in Term 2 of this Agreement for Rental, for the period specified in Term 3.
Lessee notes and gives authorisation that according to the Terms of GRAT Lessor is authorised to charge on Lessee's bank card post-rental costs such as additional fuel costs, parking or traffic fines, administrative fines, indemnifications and compensations of damages.
Lessee undertakes as binding to fully pay these costs and charges directly to Lessor if charging them on Lessee's bank card is not possible for any reason (problems with limits, bank cards, expiry, lack of enabling, etc.)
Lessee agrees that in case of any penalty, fine, insurance or similar issue, Lessor is authorised to give Lessee's personal details to the authorities and/or insurance companies.

This Car Rental Agreement was printed and signed in 2 copies, 1 of which is the copy of Lessee, and 1 of which is the copy of Lessor.

A draft Hungarian translation is an Annex of this Car Rental Agreement – in case it has to be presented for local authorities during the rental period.
